## Commissioned research: Suominen – Strong Q2, but demand slowdown in North America cuts earnings projections for H2, and especially in Q3

*Marketing material commissioned by Suominen*

Suominen reported higher than expected earnings in Q2 and provided some more colour on the reasons for the lowered outlook the company issued yesterday. As the management expects the market imbalance to be at its worst in Q3 but demand starting to recover towards the end of the year, we tentatively anticipate material downgrade to Q3 earnings expectations, some 10-20% downgrade to this year's EBITDA expectations and perhaps more modest downward revisions for 2022-23.

### Strong Q2, but outlook for H2 dampened by slower demand, destocking and higher cost

- Suominen reported higher than expected earnings with Q2 21 comparable EBITDA of EUR 15.3m coming in 11% above Vara consensus of EUR 13.8m, even if sales of EUR 114m were 5% below consensus.
- EBITDA margin of 13.4% (down from ATH 16.1% in Q1 and 14.7% from a year ago) was surprisingly resilient to the steep cost inflation seen in H1, we note.
- Guidance was lowered yesterday, as Suominen foresees 2021 comparable EBITDA to decrease from 2020 (EUR 60.9m; consensus EBITDA for 2021 was EUR 60m) due to short-term slowdown in nonwovens demand especially in North America, and volatility in input and transport costs. The guidance suggests H2 EBITDA will decline markedly from the EUR 34m in H1, to some EUR 20m or lower.
- Towards the end of Q2, especially among its North American customer base, Suominen claims it started to experience a sudden deceleration of demand, which in combination with extraordinary stockpiling throughout the entire supply chain has created an imbalance of inventories. This has impacted also Suominen's orders. Management expects demand for Suominen's products to recover once the temporary imbalance in the nonwovens market is cleared, and management's current view is that the recovery will start in Q4.
- Due to the profit warning, the share closed 12% lower yesterday (and intraday low was 21% below previous day's close). We tentatively anticipate a material downgrade to Q3 earnings expectations, some 10-20% downgrade to this year's EBITDA expectations and perhaps more modest downward revisions for 2022-23. These would leave the share valued at 6.0-6.5x 2021E EBITDA and 5.6-6.1x 2022E EBITDA.
