Commissioned research: Suominen – Slightly below consensus for Q2E – cost pressure might ease going into 2025

Marketing material commissioned by Suominen

We maintain our estimates intact ahead of Suominen's Q2 report, due on 9 August. We expect sales to turn on a growth mode in Q2, supported by improving volumes and prices. High pulp prices have persisted during Q2, while we note recent market implications for lower prices. However, owing to lag effect, we believe lower variable costs to become visible only in Q4 and in 2025. Top line development is likely to be supported in H2 by high input costs. In May, Suominen announced restructuring programme that is expected to generate EUR 1.5m annual costs savings from September 2024 onwards. Suominen expects EUR 2m one-off costs related to restructuring. We believe the company is taking right steps with its new operating model, while high pulp costs are likely to overshadow improvement in short-term. Our DCF- and multiples-based fair value range for Suominen is EUR 1.8-2.5.

We are 11% below consensus on Q2E EBITDA – EUR 1.5m annual cost savings target

On 31 May, Suominen announced a restructuring programme that is expected to generate EUR 1.5m annual costs savings from September 2024 onwards. Suominen expects EUR 2m one-off costs related to restructuring. Restructuring is expected to result in a termination of up to 10 positions in the headquarters and global support functions. Suominen announced new operating model end of last year and we view restructuring as a logical next step to align the structure of the company accordingly. Vara Research consensus is modelling EUR 36.7m adjusted EBITDA in 2025E, after EUR 26.5m in 2024E. Hence, mathematically, restructuring could give some low-single digit to consensus estimates.

For Q2E, we model 5% y/y sales growth to EUR 118m with EUR 5.2m comparable EBITDA (4.4% margin) – We are 2% ahead of consensus on top-line and 11% (EUR 0.7m) below on adjusted EBITDA. We note continued increase in pulp prices, especially in Europe. However, the most recent price points from China (as of 2 August) indicates clearly lower price levels which could also take down European and North American prices.

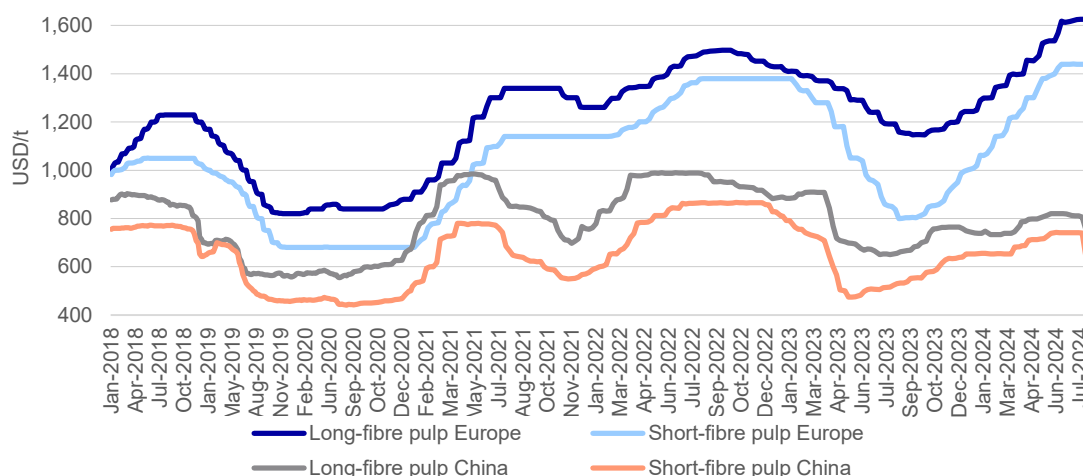
