Commissioned research: Investors House –Solid Q4 and 2025 result guided down as expected

Marketing material commissioned by Investors House

Investors House reported Q4 revenues of EUR 2.8m, 7% above our estimate. NOI was EUR 1.6m, up from EUR 0.6m y/y and 11% above our estimate. The dividend proposal for 2024 is EUR 0.35 per share, as we expected, and marks the tenth consecutive year of dividend increase. The Real Estate division's NOI was EUR 1.6m, 14% above our estimate. Fair value changes amounted to EUR +2.4m for Real Estate. The Services segment posted slightly weaker results than we had anticipated with sales down 19% y/y and operative EBIT 29% below our estimate. Services also had an impairment charge of EUR -1.5m in the quarter on one of its acquired businesses. A guidance for 2025 was introduced: earnings will decline significantly from 2024, which had several positive non-recurring items. We have expected 2025E net result of EUR 2.8m versus EUR 9.0m in 2024. We expect a neutral share price reaction.

Fair value and sensitivity

We calculate our fair values by weighting DCF, DDM, SOTP, asset-based and other standard valuation methods. Our fair values are sensitive to changes in valuation assumptions, of which growth, margins, tax rates, working capital ratios, investment-to-sales ratios and cost of capital are typically the most sensitive.

It should be noted that our fair values would change by a disproportionate factor if changes are made to any or all valuation assumptions, owing to the non-linear nature of the standard valuation models applied (mentioned above). As a consequence of the standard valuation models we apply, changes of 1-2 percentage points in any single valuation assumption can change the derived fair value by as much as 30% or more. All research is produced on an ad hoc basis and will be updated when the circumstances require it.
