Commissioned research: Atria – Negative impact from ASF above our earlier thinking

Marketing material commissioned by Atria

Atria expects EUR -7m annualised EBIT impact to its Finnish export business from ASF outbreak in Finland. The company assumes that exports to China and Japan will be discontinued while pork sales to South Korea will continue. Atria expects EUR 4-5m negative impact on 2026 adjusted EBIT but reiterates guidance for higher adjusted EBIT in 2026 (EUR 69.9m in 2025). The impact from ASF outbreak is higher than we had anticipated (low single million) while reiterated guidance point to better-than-anticipated operating performance when excluding Asia exports. We have modelled EUR 74m adjusted EBIT for 2026E. Looking into 2027E, we have anticipated EUR 78m adjusted EBIT (prior to the ASF, LSEG Data & Analytics consensus EUR 74m) and hence EUR 7m impact translates into ~9% impact. However, we believe the company can mitigate part of the impact and note that shares were down 7% last Friday when the first ASF case was published.

We calculate our fair values by weighting DCF, DDM, SOTP, asset-based and other standard valuation methods. Our fair values are sensitive to changes in valuation assumptions, of which growth, margins, tax rates, working capital ratios, investment-to-sales ratios and cost of capital are typically the most sensitive.

It should be noted that our fair values would change by a disproportionate factor if changes are made to any or all valuation assumptions, owing to the non-linear nature of the standard valuation models applied (mentioned above). As a consequence of the standard valuation models we apply, changes of 1-2 percentage points in any single valuation assumption can change the derived fair value by as much as 30% or more.
